This **full-time** position within the Association is at various locations throughout the City of Timmins and South Porcupine. Under the leadership of the Manager of Child, Youth and Family Development, the Supervisor of Child, Youth and Family Development (CYFD) is responsible for the overall operation of the child care site. The Supervisor of CYFD is required to enforce and follow the legislative and regulatory requirements set out by the Ministry of Education’s Child Care & Early Years Act, 2014 (CCEYA). In addition, this job works collaboratively with all third-party partners to ensure full compliance when it comes to municipal quality assurance programs, inclusion support agencies, local public health and fire department regulations.
